## 2023-2024 WATER SYSTEM CONTRACT

The Water Authority of Candlewood Knolls Community, Inc. upon receipt of the applicable payment will permit the connection of the private house service to the Community water main for a period of service beginning April 1, 2023 and concluding on October 31, 2023 for seasonal users. For seasonal users, this service may be extended beyond this date with the approval of the Water Authority. The conditions of service are the same as those listed in the Contract and Rules and Regulations published by the Candlewood Knolls Water Authority. Yearly water service is from April 1, 2023 - March 31, 2024.

In providing this contract, the Water Authority in no way guarantees water service or pressure, and further assumes no responsibility or liability for damages resulting from failure of service or pressure. The applicant acknowledges the conditions of the contract as offered.

**WARNING**: "SECTION L9-L3 B100 BUILDING CONVERSION: IF PUBLIC SEWERS ARE NOT AVAILABLE, NO BUILDING SHALL BE CONVERTED AS TO ENABLE ITS USE YEAR-ROUND OR SHALL ITS USE BE CHANGED UNLESS AFTER THE SAID CONVERSION OR USE CHANGE, THE LOT SATISFIES ALL OF THE CURRENT REQUIREMENTS OF THE PUBLIC HEATH CODE FOR THE INSTALLATION OF SUBSURFACE SEWAGE DISPOSAL FACILITIES EXCEPT THE ONE HUNDRED PERCENT RESERVE AREA."
